

## Free CoverPlus Promotion

### Terms and Conditions

**Promoter:** Epson Middle East FZCO, 6WA-401, Dubai Airport Freezone, Dubai, United Arab Emirates (“Epson”).

These Terms govern Epson's Free CoverPlus Promotion with eligible Epson EcoTank purchases. These terms are intended to be published together with, and read alongside, the applicable [CoverPlus Warranty Terms](#), which continue to govern the service itself, including coverage scope, exclusions, registration mechanics, liabilities, and other service conditions.

#### Promotion Period

The promotion is valid for purchases of all models of Epson Ecotank printers (the “Products”) made from **1 July 2026 until 31 July 2026**, inclusive (the “Promotion Period”). Participants must submit their claims by completing the registration form within sixty (60) days from the date of the Product purchase. The final date for submitting claims under this promotion is **31/08/2026**.

#### The Promotion

Customers who purchase at least one (1) Product during the Promotion Period will receive the Free CoverPlus Warranty cover for a total period of three (3) years from the product **purchase date** by the original end-user, or until any applicable maximum print volume or other product-specific limitation is reached, whichever occurs first. *The CoverPlus Warranty term begins on the date the product was first purchased and does not run from the date of registration or from the end of the standard commercial warranty.*

#### Eligibility

This promotion applies only to eligible Epson EcoTank printers purchased from Epson authorised resellers. The Promotion is available only to the original end-user purchaser of the eligible product and may be claimed once per eligible product serial number.

#### Registration

To claim the free CoverPlus service package, the customer must complete the required registration process on Epson [Epson CoverPlus Promo](#) and provide all information reasonably requested by Epson, including the product serial number, purchase date, and proof of purchase of the product, if requested.

Under the Epson CoverPlus Warranty Terms, registration is required for the CoverPlus Warranty to become valid, and Epson may refuse or annul cover where proof of purchase is not provided, the registration details are invalid, or registration is not completed within the applicable time period.

#### Exclusions

This promotion does not alter the exclusions set out in the Epson CoverPlus Warranty Terms. As stated in those terms, CoverPlus does not cover routine maintenance, setup, cleaning, general support, consumables, software reinstallation, calibration of connected products, or



faults caused by misuse, external damage, use outside product specifications, non-Epson approved accessories or consumables, or unauthorised repair or modification.

### **Liability**

Nothing in this promotion extends Epson's liability beyond the limits stated in the Epson CoverPlus Warranty Terms. As stated in those terms, Epson excludes liability for consequential losses, loss of profits, loss of opportunity, and loss of use, subject always to mandatory legal rights that cannot lawfully be excluded or limited.

This promotion is subject at all times to the [CoverPlus Terms](#). Nothing in these Promotion limits or affects any statutory rights that cannot be excluded by law. Epson reserves the right to request supporting documents to validate a claim and to withdraw, amend, or terminate the promotion where reasonably necessary.
