

TERMS AND CONDITIONS
EPSON 3 YEAR EXTENDED WARRANTY ON SELECTED PRINTERS

1. This offer extends the Epson Middle East FZCO (“Epson”) standard one (1) year commercial warranty provided to the original purchaser of the printers listed in the table below (“**the Selected Printers**”) to a period of three (3) years or until the maximum number of pages specified for the product have been scanned, whichever occurs first.

2. This promotion is valid for orders placed with Epson authorised resellers between **01/04/2026** and **30/04/2026** (“Promotion Period”). Participants must submit their claims by completing the registration claim form within thirty (30) days from the date of purchase. The final date for submitting claims under this promotion is **31/05/2026**.

Thirty one (31) days after the date of registration, you will be able to check that your warranty has been registered at <http://www.epson.com/eme>²

4. Epson commercial warranty shall apply to all applicable purchases irrespective of this promotion. The terms of the warranty may vary by country and product and the specific Epson entity providing warranty will depend on the country where the Epson product was first sold by an Epson entity. - d. Proof of purchase is not provided upon request for service.

11. Epson shall not be liable for any technical, printer, software, server, website or other failures or damages of any kind that impede or obstruct the participant's ability to participate in the promotion.

12. Epson reserves the right to audit all claims to ensure compliance with these terms and may request additional information or documentation relating to the claim.

13. These terms and conditions constitute the entire agreement between the parties with respect to the subject matter herein and supersede any prior agreements, arrangements, undertakings or proposals, whether written or oral related to the same subject matter.
